

## **Family Engagement Policy**

The Honors Academy of Literature agrees to implement the following requirements as outlined by Section 1116:

## **Implementation**

The Honors Academy of Literature will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to

## **BUILDING CAPACITY OF PARENTS**

The Honors Academy of Literature will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

### **BUILDING CAPACITY OF SCHOOL STAFF**
